

Guidelines for choice filling (યોઇસ ફિલીંગ માટેની ગાઇડલાઇન્સ)

- Online allotment of seats **will be** done on the basis of merit cum choice **and availability of seats** in colleges/institutes /centres as per the list provided by National Medical Commission (NMC, New Delhi). (બેઠકોની ઓનલાઇન ફાળવણી નેશનલ મેડિકલ કમિશન દ્વારા જણાવેલ સંસ્થાઓમાં મેરીટ કમ પસંદગી અને ઉપલબ્ધ બેઠકોના આધારે કરવામાં આવશે.)
- Candidates are instructed to fill all the available choices as per the list for internship programme. (ઉમેદવારોને ઇન્ટર્નશીપ મેળવવા માટે ઉપલબ્ધ બધી જ પસંદગીઓ (સંસ્થાઓ) ભરવા માટેની સુચના આપવામાં આવે છે.)
- A candidate must know that the college/institute/centre allotted to him/her is as per the choices filled by him/her and it cannot be changed in any conditions/circumstances and he/she have to join the internship programme as per the date mentioned in allotment letter. (ઓનલાઇન પ્રવેશ પ્રક્રિયા દરમિયાન દરેક ઉમેદવાર કે જેઓને કોલેજ/સંસ્થા ફાળવવામાં આવેલ છે તે તેઓની ભરેલ સંસ્થાની પસંદગી તેમજ મેરીટના આધારે ફાળવેલ છે. તથા તેમા કોઇપણ સંજોગોમાં ફેરફાર કરી આપવામાં આવશે નહીં. દરેક ઉમેદવારે તેમને ફાળવેલ કોલેજ/સંસ્થા ખાતે ફરજિયાત પણે ચોક્કસ સમયમર્યાદા (કાઉન્સેલીંગ શીડ્યુલ પ્રમાણે) માં હાજર થવાનું રહેશે.)

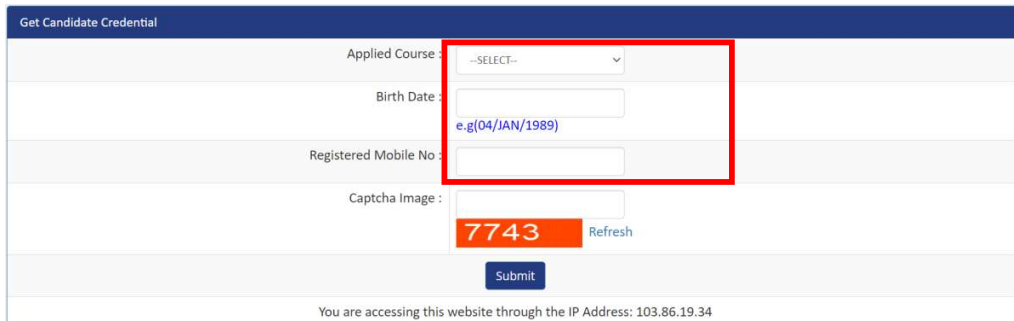
Major steps of Online Choice filling, Allotment and Reporting

- Select CRMI, Enter your date of birth and Mobile Number (Please disable DND services from your mobile before going to choice filling) provided during online registration and Enter Captcha.
- You will receive User ID and 14 digit PIN received on your mobile (**Please save User ID and 14 digit PIN for future login and do not share with any unauthorized person.**)
