Notice of CRMI for Foreign Medical Graduates (October- November 2025)

Applications are invited for **12/24/36 months Compulsory Rotatory Medical Internship (CRMI)** from Foreign Medical Graduates who have qualified the **Foreign Medical Graduate Examination (FMGE)** conducted by the **National Board of Examinations in Medical Sciences, New Delhi**, and are deemed eligible as per the rules and regulations of the **National Medical Commission (NMC), New Delhi**, from time to time. The Eligible candidates are required to apply online at <http://www.gmconline.co.in/> and submit the duly filled application form along with the required documents **in person or through an authorized representative** as per the schedule mentioned below.

1. Registration Process:

For CRMI (Compulsory Rotating Medical Internship) registration, the candidate must first apply for **FMG (MBBS) Provisional Registration** along with the prescribed fees. After successful completion of this step, the **CRMI Registration link** will be made available, through which the candidate has to fill in the required details, pay the applicable fees, and submit the application.

2	<u>Document Verification and Submission:</u> Self-attested applications (for both CRMI and FMG Provisional Registration) along with required documents must be submitted at the Gujarat Medical Council Office, Civil Hospital, Asarwa, Ahmedabad , on working days (except Sundays, 2nd & 4th Saturdays, and Government holidays).	26-09-2025 (Friday) 11:00 am to 3:00 pm	12-11-2025 (Wednesday) 11:00 am to 3:00 pm

NOTE: Document verification and submission of the application will be carried out at the **Gujarat Medical Council in person, by prior appointment only.**

2. Merit List:

- The **Merit List** will be published on the GMC website (www.gmcgujarat.org).
- No individual communication will be sent to candidates. Therefore, candidates are advised **not to make unnecessary inquiries at the Council office, either telephonically or in person, regarding the same.**

Separate Merit lists will be prepared as follows:

1. Gujarat Domicile candidates.
2. Diu, Daman & Dadra Nagar Haveli (Union Territory) Domicile candidates
3. Gujarat Non-Domicile candidates (other than Gujarat State & Diu, Daman, Dadra Nagar Haveli (Union Territory))
4. **NOTE:** (1) Gujarat Non-domicile candidates (other than Gujarat State & Diu, Daman, Dadra Nagar Haveli (Union Territory)) who apply for Gujarat are required to pay a **refundable security deposit of ₹1,00,000/-** in the form of a **Demand Draft** drawn on a nationalized bank, payable at Ahmedabad, in favor of **“Registrar, Gujarat Medical Council.”** If a candidate does not join the allotted institute for internship or discontinues the internship after joining at anytime during the period of internship, the security deposit of ₹1,00,000/- will be forfeited.
(2) The refundable security deposit of ₹1,00,000/- will be returned to candidates who successfully complete the internship and obtain **permanent registration** with the Gujarat Medical Council.

Merit List will be published according to following criteria:

- (A) The merit list will be prepared on the basis of the **NBE score** obtained by the candidate.
- In case two or more candidates have the same NBE score, the merit order will be determined as follows:
1. Candidate securing a higher percentage of **PCB (Physics, Chemistry, Biology) theory marks** in the HSC examination.
 2. If still the same, the candidate securing higher **theory marks in Biology** in the HSC examination.
 3. If still the same, the **older candidate** will be placed higher.
- (B) Candidates included in the merit list are advised to participate in the **online counseling process** as per the schedule announced by the Gujarat Medical Council.



3. Allotment process:

- Allotment process for Gujarat State and NAMO Medical College, Silvassa seats will be given in the following order:

Seats of Gujarat State	Seat of NAMO Medical College, Silvassa
1. Gujarat Domicile candidates.	1. Diu, Daman & Dadra Nagar Haveli Domicile candidates (U/T).
2. If seat remains vacant then, Diu Daman & Dadra Nagar Haveli Domicile candidates.	2. If seat remains vacant then, Gujarat Domicile candidates.
3. If still seat remains vacant then, Gujarat Non-Domicile candidates. (other than Gujarat State & Diu, Daman, Dadra Nagar Haveli (Union Territory))	3. If still seat remains vacant then, Gujarat Non-Domicile candidates. (other than Gujarat State & Diu, Daman, Dadra Nagar Haveli (Union Territory))

- Seats will be allotted only to candidates whose names appears in the **Merit List** published by the Gujarat Medical Council.
- Allotment of seats shall be made on the basis of the candidate's **merit number, choice of institute, and availability of seats**.

IMPORTANT NOTE:

All candidates are hereby informed that once an internship seat is allotted through the online allotment process, the seat **cannot be cancelled** in any circumstances.

Candidates who are allotted a seat but fail to join, discontinue, or do not complete their **CRMI (Compulsory Rotating Medical Internship)** for any reason whatsoever shall be subject to the following actions:

• **Gujarat Domicile & Diu, Daman & Dadra Nagar Haveli Domicile Candidates:**

- (a) The Candidate shall not be eligible for internship again.
- (b) The candidate's application fees for both FMG Provisional and CRMI will be forfeited.
- (c) **Provisional Registration** of the candidate shall be cancelled.
- (d) The candidate shall not be eligible for **Permanent Registration**.
- (e) The matter will be reported to the **National Medical Commission (NMC)**.



• **Gujarat Non-Domicile Candidates: (other than Gujarat State & Diu, Daman, Dadra Nagar Haveli (Union Territory)):**

- (a) The deposited amount of **₹1,00,000/-** shall be forfeited.
(b) The Candidate shall not be eligible for internship again.
(c) The candidate's application fees for both FMG Provisional and CRMI will be forfeited.
(d) **Provisional Registration** of the candidate shall be cancelled.
(e) The candidate shall not be eligible for **Permanent Registration**.
(f) The matter will be reported to their **concerned State Medical Council** as well as the **National Medical Commission (NMC)**.
