Notes:


1. Allotment will be done as per merit cum preference depending on availability of seats.
2. Only one person, either candidate or on his/her authorized person is allowed to remain present at counselling venue. Candidate or his/ her authorized representative should report at the place of counseling 30 minutes prior to scheduled time with all original documents. In case of absence at given time candidate will loss his/ her claim for allotment/ choice.
3. The Selected candidates are expected to join the internship programme on **16-05-2023**. Internship duration is extending from **16-05-2023 to 15-05-2024**. Candidate can report to allotted college/ institute prior to **16-05-2023** for original document verification and posting order and other things/arrangements, but his/ her internship will start from **16-05-2023** only.
4. Allotment process:
 - The seats will be allotted to candidates whose name appear in the Merit List published by Gujarat Medical Council.
 - Allotment of seats shall be made on the basis of merit number of the candidate and availability of seats.
 - Video recording of whole counselling process will be done. So, candidates are advised to select their college/institute carefully. Once selected/allotted college/institute cannot be changed in any condition/circumstances.



5. Every candidate has to come with notarized affidavit of Undertaking (Format available on council website: <http://www.gmcgujarat.org/>) on Rs.100/- stamp paper.
6. As per instructions provided by NMC, Gujarat Medical Council is allotting college/institute to the eligible candidates for the purpose of internship. The internship completion certificate, payment of stipend and hostel accommodation will be provided by respective college/institute as per the norms of National Medical Commission/ Government of Gujarat/ concerned University. The Gujarat Medical Council is not responsible for payment of stipend, accommodation etc.
7. After completion of CRMI, candidate has to collect internship completion certificate from the allotted college/institute as per NMC / University/ Govt. of Gujarat rules & regulations.
8. The candidate has to follow all rules and regulations of National Medical Commission, Gujarat Medical Council, concern University and concern college/institute.
9. The Candidate is solely responsible for his/ her involvement in any kind of unlawful activities whether inside or outside the campus, and shall be liable for punishment as per the law of the land. The candidate further understand that the college/institute shall in no way provide any support to him/ her and will not be held responsible for his/ her any such action. Any kind of misbehavior or violation of rules will result in termination of his/ her internship at allotted college/institute. College/ Institute can take disciplinary action as per the prevailing norms of University/ Govt. of Gujarat/ National Medical Commission/ Gujarat Medical Council.
10. Allotted college/ institute will check all original documents and eligibility at the time of reporting. The college/ institute can refuse joining of Candidate in case of any discrepancy found in it. Original documents have to be submitted to the Dean of allotted medical college/ Institute by the candidate.
11. Candidate must bring all original required documents and undertaking at the time of counselling process failing which his/ her candidature will not be considered for counselling process.
