Notice of CRMI for Foreign Medical Graduates (MAY 2023)

Applications are invited for 12 months **Compulsory Rotatory Medical Internship (CRMI)** as per the guidelines of National Medical Commission (NMC), New Delhi from Foreign Medical Graduates students who are **domicile of Gujarat State** and who had passed Foreign Medical Graduate Examination conducted by National Board of Examination, New Delhi and qualify & eligible as per rules & regulations of National Medical Commission, New Delhi from time to time. The candidate has to apply online through the link provided on <http://www.gmcgujarat.org/> and submit the application form with required documents in person or through authorized person as per below mentioned schedule.

Please be noted that any application submitted by Gujarat State NON DOMICILE applicant will be straight a way rejected and its fees paid shall be NON REFUNDED and No queries in this regards will be entertained by the council later on.

1. Registration Process:-

For the purpose of registration, candidate shall be required to apply online and make payment of **NON REFUNDABLE** Total Rs. 5000/- (Registration fee Rs. 1000 + Processing fees Rs. 4000), via online mode as per guidelines provided in the registration link.

2. Merit List:-

- Merit list and tentative Seat List will be published on GMC website (www.gmcgujarat.org) later on. No individual information will be given to the candidates.

Merit list will be published according to following criteria:

- Merit list will be prepared based on NBE score obtained by the candidate.

In case of more than one candidate have same NBE score merit order will be determined on the basis of following criteria:

(a) Candidate who has secured higher percentage of PCB theory marks in HSC examination.

(b) Candidate who has secured higher percentage of Biology theory marks in HSC examination.

(C) Candidate who is older

- Eligible candidates are advised to participate in counseling process as per the schedule announced by GMC with all necessary original document and affidavit (**Annexure 1**) at the time of counselling

3. Allotment process:


- The seats will be allotted to candidates whose name appear in the Merit List published by Gujarat Medical Council.
