Notice of CRMI for Foreign Medical Graduates (MAY-JUNE 2025)

Applications are invited for 12/24/36 months Compulsory Rotatory Medical Internship (CRMI) as per the guidelines of National Medical Commission (NMC), New Delhi from Foreign Medical Graduates students who had passed Foreign Medical Graduate Examination conducted by National Board of Examination, New Delhi and qualify & eligible as per rules & regulations of National Medical Commission, New Delhi from time to time. The candidate has to apply through online mode on http://www.gmconline.co.in/ and submit the application form with required documents in person or through authorized person as per below mentioned schedule.

1. Registration Process: -

For the purpose of the CRMI (Compulsory Rotating Medical Internship) registration, firstly candidate has to apply for <u>FMG (MBBS) Provisional Registration</u> along with required fees and then after <u>CRMI (Compulsory Rotating Medical Internship)</u> <u>Registration</u> link will be available in which candidate has to fill in the required information and fees and submit it.

2. Merit List:-

 Merit list and tentative Seat List will be published on GMC website (www.gmcgujarat.org) later on. No individual information will be given to the candidates, hence do not unnecessarily inquire at the council office in this regard telephonically or personally.

3. Separate Merit list will be prepared for the Domicile and Non-domicile candidates

- 1. Gujarat Domicile candidate list
- 2. Diu, Daman & Dadra Nagar Haveli domicile candidate list (Only eligible for NAMO Medical College, Silvasa and if seats are full, they will be considered in non-domicile category and shall not be entitle for Gujarat Domicile seats)
- 3. Non-Domicile candidate list.
 - NOTE: (1) Non-Domicile candidates are requiring to pay the Rs. 1 lakh as a Refundable Security Deposit in form of Demand Draft by name of "Registrar, Gujarat Medical Council" of nationalized bank payable at Ahmedabad. If candidate do not join to allotted institute for internship or leave internship in between after allotment then deposit of Rs. 1 lakh will be forfeited.
 - (2) Rs. 1 lakh Refundable Security Deposit will be given back to the candidates who completed the Internship satisfactorily and get the permanent registration of Gujarat Medical Council.

Merit list will be published according to following criteria:

Merit list will be prepared based on NBE score obtained by the candidate.

In case of more than one candidate have same NBE score merit order will be determined on the basis of following criteria:

- (a) Candidate who has secured higher percentage of PCB theory marks in HSC examination.
- (b) Candidate who has secured higher percentage of Biology theory marks in HSC examination.
- (C) Candidate who is older
- Eligible candidates are advised to participate in Online counseling process as per the schedule announced by Gujarat Medical Council.

4. Allotment process:

- The seats will be allotted to candidates whose name appear in the Merit List published by Gujarat Medical Council as per the Merit List (1) (2) and then remaining seats allotted to Merit List (3).
- Allotment of seats shall be made on the basis of merit number cum choice of the candidate and availability of seats.

IMPORTANT NOTE: It is to inform to all Domicile and NON- Domicile applicants that once the internship seat is allotted by online allotment process, said seat cannot be abandoned. Those who have been allotted the seat and do not join & complete their CRMI (Compulsory Rotating Medical Internship) will not get the internship again for

what so ever reason may be. If applicant leaves allotted CRMI in between for what so ever reason, it will be reported to National Medical Commission and applicant's concern State Medical Council for taking appropriate action.
